Our Safeguarding Policy

The vision of Bentley Baptist Church is to recognise the importance of its ministry/work with children, young people and vulnerable adults and takes responsibility to protect everyone entrusted to its care.

This policy applies to all Church Leadership, members, paid staff, volunteers or anyone working on behalf of Bentley Baptist Church including Renew127 Centre.

All church attendees & workers in Renew127 Centre have a part to play and should be alert to situations where children/young people and vulnerable adults are at risk.

Information will be placed throughout the church building/ meeting rooms and 127 Centre giving details of who to contact if there are any concerns about the welfare of a child/young person or vulnerable adult.

The Policy and Procedures will be made available on the Bentley Baptist Website.

This church believes that a child/young person or adult entrusted to its care should never experience abuse of any kind and we will work to promote the welfare of all to keep them safe.

This church is committed to the safeguarding of children and young people, to ensure their well-being in compliance with the Governments inter-agency statutory guidance 'Working Together to safeguard children' March 2015 and CCPAS (The Churches' Child Protection Advisory Service) 'Safe and Secure' safeguarding standards.

This Church is committed to following the 'No Secrets' guidance for adult safeguarding (updated January 2015)

We are Specifically Committed to:

- Supporting the designated Safeguarding Person and Deputy within the church
- Supporting the Minister and Trustees of the church in their responsibilities to adopt and implement the church's safeguarding policy.
- Ensuring appropriate pastoral support is provided in the context of any safeguarding investigation
- We commit ourselves to the nurturing, protection and safekeeping of all; especially children, young people and Vulnerable Adults and to ensure they are not treated less favourably than others with regard to gender, ethnicity, disability, sexuality or beliefs.
- We accept that the responsibility of each one of us is to prevent all forms of abuse of children, young people and all who attend our church wherever possible and to report any abuse discovered or suspected. Safeguarding is everyone's responsibility.
- We undertake to exercise proper care in the selection and appointment of those working with children, young people and vulnerable adults, whether paid or working on a voluntary basis and to ensure where appropriate, they are DBS (Disclosure and Barring Service) checked.



- The church is committed to supporting, resourcing and training those who work with children, young people or vulnerable adults and to provide appropriate supervision.
- The church is committed to following current UK legislation and implementing the requirements of government guidance in regard to people with disabilities.
- The policy will be reviewed, approved and endorsed by The Church Leadership annually or when legislation changes and will be communicated to Church Members at least yearly
- We commit to supporting the safeguarding designated people in their work and in any action, they may need to take in order to protect children/vulnerable adults.

We recognise:

- The welfare of the child/person is paramount
- Some children/people are additionally vulnerable because of the impact of previous experience
- We need to provide a safe physical environment for our children, young people, vulnerable adults, congregation, staff and volunteers by applying health and safety measures in accordance with the law and regulatory guidance
- Using our safeguarding procedures, we will share concerns with relevant agencies that need to know.
- Children's Social Services (or equivalent), Local Authority Designated Officer LADO and Police have lead responsibility for investigating all allegations or suspicions of abuse where there are concerns about a child. Adult Social Care (or equivalent) has lead responsibility for investigating all allegations or suspicions of abuse where there are concerns about a vulnerable adult.
- Where an allegation suggests that a criminal offence may have been committed then the police should be contacted as a matter of urgency.
